Honorable Greg Griffin was appointed to the 15th Judicial Circuit of Montgomery County Alabama on November 26, 2014 to complete the remainder of Retiring Judge Tracey McCooey's six year term by Governor Robert Bentley. Judge Griffin won a contested race in March of 2016 in the Democratic Primary. He does not have opposition in the general election. Prior to his appointment Judge Griffin was the Chief Legal Counsel, Attorney IV for the Alabama Board of Pardons and Paroles, Montgomery, Alabama for more than 19 years. The Chief Legal Counsel provides oversight, guidance and direction for legal advice provided throughout the department as well as providing

advice on any legal subjects and on other matters as directed by the Alabama Board of Pardons and Paroles.

Prior to being employed as Chief Legal Counsel, Judge Griffin was an Assistant Attorney General in the Attorney General's Office, where he specialized in civil litigation and criminal appellate practice. He was also General Counsel to the Alabama Board of Veterinary Medicine. Judge Griffin was also an Adjunct Instructor at Alabama State University teaching courses in Real Estate Finance, Business Law I and Federal Income Taxation. He served in that position from 1989 to 2002. Judge Griffin was also the Chairman of the Board of Governors of the Capital City Club in Montgomery, Alabama in 2002. He was also appointed by Governor Bob Riley and unanimously confirmed by the Alabama Senate to serve a 10 year term as Vice Chairman of the Alabama Educational Television Commission. Judge Griffin retired from the State of Alabama on January 1, 2015 after 27 years and 4 months of dedicated service. Judge Griffin was elected in the March 2016 Democratic Primary receiving 63% of the vote. He is unopposed in the General election. Judge Griffin's new 6 year term will begin in January 2017.

Judge Griffin and his wife Debra have been married 29 years. They are the proud parents of six children. Greg Jr. is a graduate of the University of Pittsburgh School of Law and a 2nd Lt. in the Alabama National Guard. Alexis is a second year medical student at South Alabama College of medicine in Mobile, Alabama, Christopher is a Larson Fellow and rising senior at Carleton College in Northfield, MN. Calvin, Natalie and Sean are students in the Montgomery Public School System.

Judge Griffin and his family were among the 21 persons who founded the Community Congregational United Church of Christ located on the corner of South Court Street and Edgemont Avenue in Montgomery, Alabama where he is currently a member. He served on the Executive Council for approximately four years.
